President's Report

The year 2004-2005 has been one of numerous changes and exciting initiatives by the Society, starting with its administrative complement. I took office as President last June, joined by new Vice-Presidents Jack Bumsted and Harry Duckworth. Additions to the Council were Simon Lucy, Gillian Covernton, and Scott Stephen. At the conclusion of this Annual General Meeting, we will say goodbye and sincere thank-you to Judith Hudson Beattie, who leaves the Executive after several years of service as Secretary. We also lose the input on the Council of Jim Blanchard (former Past President), Peter Bower, Shirley Bradshaw, Garry Brickman, and Irene Shaw. I am grateful to these folks for their dedicated service, and hope that we can count on their active participation in other aspects of Society operations in the years ahead. Remaining members of the Executive and Council likewise deserve our support and thanks, for their numerous hours spent attending meetings as well as other functions, and for moving forward the Society agenda.

The MHS staff continue to be challenged to provide a range of services with less-than-unlimited resources, and they have done so cheerfully and diligently. I wish to especially acknowledge Jacqueline Friesen for her dedication and professionalism as the all-important "public face" of the Society at our office, particularly during the disruptive period after the move. Linda Neyedly and Monique Woroniak have recently joined the staff at Dalnavert, and Victor Sawelo returns as the seasonal manager at Ross House. Thank you all.

In a largely volunteer-based Society such as ours, it is difficult to acknowledge fully the hard work of people on committees, without whom many of the benefits that members enjoy would be severely curtailed. I refer you to the reports elsewhere in this document for details on the activities of these committees during the past year. I draw special attention to the Dalnavert Management Committee, chaired jointly by Jim Blanchard and Stephanie Middagh, which has faced special challenges over the past year during construction of the Visitors Center.

In June 2004, the Society celebrated its 125th anniversary with a ceremony at the provincial Legislative Building. Our relationship with the provincial government was strengthened when The Honourable John Harvard, P.C., O.M., who took office as Lieutenant-Governor of Manitoba last June, accepted an invitation to become our patron, continuing the practice of his predecessor. Mr. Harvard indicated that he was keenly interested in promoting Manitoba's history during his term of office, and we look forward to working closely with him in this respect. He attended several of our functions during the year, including the Macdonald Dinner, our annual awards ceremony (where he presented the Centennial Organizations and Margaret McWilliams awards), and the Dalnavert Visitors Center ribbon cutting. We also worked closely with Mr. Harvard to present, along with Canada's National History Society, a "Lieutenant-Governor's History Pick of the Week" on his web site.

The 2005 Sir John A. Macdonald Dinner was a rousing success. The featured speaker was The Right Honourable John N. Turner P.C., C.C., Q.C., 17th Prime Minister of Canada. Mr. Turner spoke about his recent visits to Ukraine to monitor the national elections there, and he spoke passionately about Sir John A, including his initiation of a commemorative dinner in Kingston, Ontario. A new item on the evening's agenda, a silent auction of over 40 donated items, was generally well received and lucrative.

Many thanks to the committee which organized the dinner, chaired by Margaret Morse. They acquitted themselves admirably despite the unexpected death of committee member (and MHS Councillor) John Bovey just before the dinner.

A new Membership Committee was struck, consisting of Councillors Carol Scott (chair), Bill Fraser, Steve Place, and Gillian Covernton, to develop a strategy to increase membership. We trust that the committee's efforts will bear fruit in the coming year. Results of a survey conducted by the committee indicated, among other things, that members favor more frequent publication of our newsletter and journal. As a step toward fulfilling this desire, the Society also formed a Publications committee, chaired by Jack Bumsted and consisting of the newsletter editor (Bill Fraser), journal editor (Bob Coutts), webmaster (myself), and member-at-large Laird Rankin. Its purpose will be to foster greater coordination between the Society's publications. One of the committee's first recommendations, approved by the Council in May, was to increase the publication frequency of *Manitoba History* from two to three times per year. It is hoped this will be the first step on the way to making the journal a quarterly.

In July, the MHS office was moved from the Grain Exchange Building on Lombard, where it had been located for over 12 years, to the Merchants Building on McDermot. The move was precipitated by the ever-increasing rent in our former location. The new office is situated within the historic Exchange District, in a refurbished early 20th century garment factory. It is about the same size as our former space but it is better suited to the public display (and use) of our library books. New shelving was acquired using funds provided by a bequest to the Society, and the library was formally designated the Edwin Nix Memorial Library. A library acquisition policy developed by Jim Blanchard was adopted in early 2005, under which we will de-accession books deemed not directly pertinent to the Society's mandate, while acquiring a more comprehensive collection of local history books.

The MHS constitution has not been reviewed for several years, with the result that it now contains several obsolete sections. A constitutional review subcommittee consisting of Councillors Garry Brickman, Alan Crossin, Steve Place, and Harry Duckworth was struck, and it drafted a comprehensive new constitution which has been endorsed by the Council and will be brought for ratification to an upcoming Special Meeting of the membership. Meanwhile, formal policies were developed by the Executive and Council on the reciprocal benefits accruing to affiliated societies and the MHS, and the protection of member privacy and personal information. A policy respecting the acceptance and disposition of gifts-in-kind is being developed.

Perhaps the most significant changes in 2004-05 took place at Dalnavert Museum, where construction of a \$1.5 million Visitors Center was completed recently. The building, designed by conservation architect Wins Bridgman, features numerous aspects of "green technology" for minimizing resource consumption. It will give the Society a great facility for hosting meetings, exhibits, and other functions, and we anticipate that it will be an important catalyst of renewal at the museum. In May, the Council approved the naming of the meeting space in the Visitors Center as the C. Steward Martin Auditorium, in time for the dedication and ribbon-cutting ceremony on the 14th. Another change at Dalnavert was the departure of long-serving staff members Tim Worth and Nancy Anderson. In recognition of Tim's nearly 30 years of service as Curator at Dalnavert, he was given an Honorary Life Membership at a retirement party held at the University Womens Club.

The MHS is occasionally approached by members of the general public to offer moral support to one project or another. In response to one such inquiry, we became actively engaged in the public debate over plans to develop a mult-family residence building at 500 Taché immediately adjacent to the St. Boniface Museum. The MHS Council carried a motion opposing this project on the grounds that it unduly compromised the site. Regrettably, the proposal was upheld on appeal by the Winnipeg City Council and construction is anticipated to commence soon.

Looking toward the future, the Margaret McWilliams award will be presented for the 50th consecutive year in 2006, making it one of Canada's oldest book prizes. A committee is being organized to develop plans for a special commemoration of this milestone. Meanwhile, a former offshoot of the MHS is coming to an end. The Manitoba Record Society, formed in 1960 to publish rare and important documents relating to our province's past, will wind up its operations later this year and transfer its remaining physical and financial assets back to the MHS. As part of this process, the MRS is having its twelve books converted into digital form, which will enable us to deliver them free-of-charge on our web site. This will be the first step in the development of an online library of rare and unpublished manuscripts which we hope will continue the legacy of the MRS in the digital realm.

In conclusion, it was been an honour to serve as your President for the past year, during which time I have learned a lot, and met many great people in the heritage community. I pledged at the beginning of my term to offer new ideas for your consideration, and to actively solicit discussion. I look forward to further progress on these fronts during the coming year.

Treasurer's Report

The general operating revenue of the Society for the 2004 - 2005 fiscal year, including the net revenue from projects, decreased from \$69,728. to \$61,552. If we remove the bequests received from both years, the operating revenue increased from \$53,978, to \$56,552. Revenue from membership fees and donations increased from \$17,284. to \$22,397., an increase of \$5,113. This increase is primarily due to an increase in donations and is a welcome increase as memberships fees and donations have been decreasing in the past.

The general expenditures of the Society increased from \$67,482. to \$73,586., an increase of \$6,104. A major portion of the increased expenditure was due to the library shelving in the new offices. This was funded by a portion of the bequest received in 2003 - 2004 which had been allocated to this expenditure. Other one-time costs related to the move of the office and upgrading the accounting system amounted to approximately \$3,200. This was partially offset by a reduction in the rent in the new location.

Net revenues from projects declined from \$11,011. to \$4,099. Part of the decrease is attributed to the method of accounting for the Province of Manitoba operating grant. The full amount of the \$25,200. grant has been treated as general revenue while in the past, \$4,300. of the grant was attributed to the Manitoba History project. In addition, net revenue from the Sir John A. Macdonald dinner declined from \$10,678. to \$7,353., a decrease of \$3,325. The exact details of the changes in net revenues from projects is outlined in Note 5 to the financial statements. We continue to look for sponsors for several of the projects, in particular Centennial Farms and Centennial Organizations.

With respect to Dalnavert, comparison of the operating results is difficult because of the substantial changes due to the closure of the house to the public during the period of construction. However, due to an increase in the transfer of funds from the Heritage Trust to \$50,000. for the year and an excess of expenses over revenue of only \$2,770., the Dalnavert surplus has increased from \$25,927. to \$73,157. which will be of assistance in the next couple of years as the new addition to the house and the changes in programming are put into place.

As I have expressed in the past many times, we continue to experience a lack of sustained growth in the areas of membership revenue and donations for operations. The current basic operating expenses of the society, excluding Dalnavert costs but including the net cots of the Centennial Farms and Manitoba History projects, amounted to approximately \$72,000.00 for the 2004 – 2005 year. If we reduce that by the \$25,000. grant from the Province, we need to raise approximately \$47,000. from membership, donations and fund raising such as the Sir John A. Macdonald dinner just to meet these basic costs. For 2004 – 2005, these three sources of income amounted to approximately \$30,000., leaving a shortfall of about \$17,000. to be raised or will become a further reduction of our surplus.

The areas of membership and donations need to be increased substantially to support the day-to-day operations of the Society so that our reliance on the fundraising for operating expenses can be diminished and fundraising can be channeled for new initiatives of the Society. Our surplus has been diminishing due to the deficits of the past few years and every effort must be made in the years ahead to ensure at least a break-even position each year.

To all those that have "gone the extra mile" in the last year to support the Society, particularly those involved with the Dalnavert addition, I once again can only extend my gratitude and look forward to your continued support in the future. In particular, I would once again thank Jackie Friesen for all of her dedication to the society over the past years.

Award Programs

Centennial Business Awards

In 1999 the Manitoba Historical Society initiated the Manitoba Centennial Business Awards to recognize businesses that contributed to the development and character of the province for over one hundred years. Kenneth A. Zealand Chartered Accountant has sponsored the award since its inception. The firm he is now working with, Meyers Norris Penny, is continuing that sponsorship, for which we are very grateful.

This year three businesses received the award: Christie's Office Plus (1881 in Brandon), Ash Temple Limited (1895) and Winnipeg Supply Service Experts (1904). They join the eighteen previous recipients: Hudson's Bay Company; The North West Company; Burrows Lumber Inc.; Wilson Furniture Ltd.; Wawanesa Mutual Insurance Company; H.P. Tergesen store in Gimli; Brown and Rutherford; Hartney Machine and Motors; Winnipeg Free Press; Arctic Glacier; J.J.H. McLean & Co. Ltd.; Pringle's Men's Wear in Boissevain; Trim Services Ltd.; Thomson Funeral Services; Reesor's Jewellery of Brandon; James Richardson and Sons, Ltd., and the law firms Pitblado and Aikins, Macaulay, Thorvaldson.

Last year one special joint award with the Manitoba Community Newspapers Association was presented to The Western Canadian of Manitou, founded in 1900. Nineteen other newspapers have been honoured in the past.

In celebration of the 125th Anniversary of the MHS, special awards were presented in May 2004 to the following hotels: the Woodbine (1878); the Winnipeg (1881); the Queens of Rapid City (1881); the New Occidental (1886); the Vendome (1898); the Windsor (1903); and Mariaggi's (1903).

We would welcome suggestions of worthy recipients for future awards.

Margaret McWilliams Awards

The Manitoba Historical Society Margaret McWilliams Award was established in 1955, through the generosity of former Lt. Governor Roland F. McWilliams, as a memorial to his late wife, Margaret McWilliams.

Margaret McWilliams served as president of the Manitoba Historical Society, and, along with W. L. Morton, is credited with revitalizing the Society after the war years. Margaret McWilliams made many significant contributions to Manitoba during her lifetime, as a journalist, politician, activist and historian.

The 2005-06 Awards will be the 50th Anniversary of the award program, making this award one of the oldest in Canada. To commemorate this occasion as well as the 125th Anniversary of the Society in 2004, the program has undergone many exciting changes. The award criteria has been updated to meet a wider range of publications and print media, as well as audio, visual, and web based projects. Our subject matter remains Manitoba based, however, and submissions are sought worldwide, as long as the are in keeping with our criteria. In addition, a \$25.00 submission fee has been introduced for the book category only.

Award presentations were made at the Society's second annual awards event held at St. John's College, (University of Manitoba) on April 3, 2005, by the Honourable John Harvard, P. C., O. M., Lieutenant Governor of Manitoba and Patron of our Society; with Ron Robinson of CBC radio as master of ceremonies.

Young Historians Awards

In 2004 the Society received 100 entries for our annual competition, with 38 winners. As in the past, entries from private schools dominated (1 from St. John's Ravenscourt, 8 from Holy Ghost, 22 from Balmoral, 24 from St. Mary's). However, a growing number of schools from across the province participated, including St. Francois Xavier, Deloraine, Shoal Lake, Langruth, Roseau Valley, Portage and Yellowquill, and the city schools of General Byng, John Taylor, Lord Wolseley, Robert H. Smith and Gordon Bell. We are working with Heritage Fairs to recognize different skills. MHS focuses on written papers, and includes Senior 3 and 4 students while Heritage Fairs emphasize oral presentations and exhibits. Our decision to restrict the competition to Manitoba history has not resulted in any reduction in the quality or number of submissions, and fits with the Society's mandate. We plan to continue this policy.

The Awards ceremony was held in Grant Park High School on 24 October 2004, with more than 200 attending. Communications & Publications

Publications Committee

The committee, which consisted of J. M. Bumsted (chair), Bob Coutts as editor of *Manitoba History*, Bill Fraser as editor of the Newsletter, Gordon Goldsborough as editor of the Website, and Laird Rankin as a member-at-large, held its organizational meeting in September 2004.

At its first meeting, the committee drafted its terms of reference, which were passed on to the Executive and Council for approval.

The committee met a number of times during the year, making a number of recommendations for improvement to the Society's publications programme. For *Manitoba History*, it recommended an expansion of publication frequency from two issues to three (for 2005) and eventually to four (for 2006). It also recommended that the expanded journal carry advertising and increase its prices.

For the Newsletter, the committee recommended a change of name, with *Timelines* ultimately decided upon as the new name on the masthead. The committee also recommended that the Newsletter consider making itself available in on-line format for those who would prefer to receive it electronically.


The committee urged the Dalnavert Management Committee to stock MHS publications in its new shop.

Because the Council had decided in the autumn to withdraw the Society's McWilliams awards from the "Brave New Worlds" prize-giving event, the Publications Committee agreed to serve as the interim organizer and co-coordinator of the newly separated McWilliams Prize giving for 2005. It also recommended that the terms of reference of the McWilliams Prize committee be revised to reflect the new situation, changing from one serving solely as a jury to adjudicate the McWilliams prizes to one that would not only supervise the adjudication of the prizes but would organize and co-ordinate the prize giving event. It was noted that 2006 would represent the 50th anniversary of the McWilliams Prizes, which should be commemorated accordingly.

Web Site

The web site (www.mhs.mb.ca) has expanded greatly in the last year, its traffic continues to increase (see graph), and we are receiving an increased volume of public inquiries arising from material on the web site. Manuscripts have been submitted for publication in *Manitoba History* as a result of publicity gained through our web site.



June 2003, we began a long-term project to provide online access to as many of the Society's publications. The project subsequently received the support of Heritage Grants from the provincial government in Fall 2003 and Spring 2004 which enabled us to employ students to assist with the work. I volunteer a substantial amount of time to complete the work of converting digitized documents into a format that can be displayed on the web site.

At present, all but a handful of the *Transactions of the Manitoba Historical and Scientific Society* (1882 to 1980) are online, the exceptions being ones that were republished in book form by the University of Manitoba Press in 2002. (We are withholding these temporarily so as not to interfere with book sales.) All *Manitoba Pageant* issues are online. We have begun the digitization process for our present journal, *Manitoba History*, and have completed the first fifteen issues (1980 to 1988). We anticipate completing all issues of the journal by the end of the summer. All but the most recent five years (which are provided online by commercial services, for which the Society receives royalties) will be made available.

Development of content for the web site, especially digitization of our publications, was made possible through grants received from the provincial government's Historic Resources Branch. The grant required us to work at two bingos at the city casinos. Thanks are due to volunteers who helped: Judith Hudson Beattie (x2), Jim Blanchard (x2), Harry Duckworth, Mary Lynn Duckworth, Peter Bower, Bill Fraser, Len Goldsborough, Carl James, Margaret Morse, Elizabeth Place, Steven Place, Victor Sawelo (x2), Bob Sutton, Evelyn Sutton, and Maria Zbigniewicz.

Some of the other additions to the web site over the past year were as follows:

- A forum (www.mhs.mb.ca/forum) was created on which people can post questions and information, exchange ideas, and discuss Manitoba history.
- A series of short articles based on documents on the web site were provided to the Lieutenant-Governor's office to be featured on his web site as "Manitoba History Pick of the Week" along with a link back to the originals on our site.
- Photographs for the "Manitoba History Photo of the Day" feature were uploaded to cover an entire year.
- Descriptions and photographs of the Dalnavert Visitors Center were provided during the period of construction.
- All past recipients of Margaret McWilliams awards, from 1960s to present, were tabulated. Brief profiles on all Centennial Business and Centennial Organization award recipients were uploaded.
- The federal top-level domain "mhs.ca" was registered for a period of three years after we were informed that an unknown person was attempting to register it. We were concerned that confusion could occur if www.mhs.mb.ca and www.mhs.ca referred to different web sites. Visitors will be able to use either domain to reach our site.
- We are working with the Manitoba Record Society to obtain digital copies of its twelve books, published over the past forty years. Free access to these books will be provided on our web site, probably in the fall, along with other rare and unpublished manuscripts relevant to Manitoba and Canadian history.

One mailing was combined with the mailing of Manitoba History and more joint mailings are expected in the future as a cost-saving measure.

The newsletter now operates in association with the MHS publications committee.

MHS Members are encouraged to provide material for the editor and to make suggestions on improvements for future newsletters.

The Autumn/Winner issue (number 48) contained articles by Lyle Dick - Nationalism and Visual Media in Canada: The Case of Thomas Scott's Execution, and Sarah Carter- Your Great Mother Across the Salt Sea: Prairie First Nations, The British Monarchy and the Vice Regal Connection to 1900.

With this issue, we bid a fond farewell to long time Gazette editor, Rosemary Malaher, and we thank her for her dedication over the years. Rosemary has submitted many articles to the Journal, and we hope she will continue to do so. This issue debuts and welcomes our new Gazette editors, Gillian Covernton and Scott Stephen, both members of MHS Council.

In 2005, the Journal will be celebrating its 25th Anniversary. With this milestone, many exciting developments have been initiated to enhance our publication. An editorial board has been formed, the journal will be published 3 times per year instead of 2 issues and the journal will now carry advertising, starting with the Spring/Summer issue in June 2005.

We would like to acknowledge the funding support from the Department of Culture, Heritage and Tourism, as a portion of the operating grant of the Society is allocated towards the publication of the Journal.

Now the building is complete and the Grand Opening on May 14. The \$1.5 million project, which came in on budget and is completely paid for, will expand the types of programs and activities that we can offer at the Museum, as well as providing some much-needed income.

It has been a year of enormous change at Dalnavert and both Curator Tim Worth, who retired, and Assistant Curator Nancy Anderson, whose position was discontinued as part of the restructuring, have left the employ of the Society. Linda Neyedly is the new Director of Dalnavert and she began work on April 18, 2005. Linda was formerly the Development Officer of the Western Canada Aviation Museum and has held a number of other management and information officer positions in the City.

There is a new Management Committee in place as well. The co-chairs are Stephanie Middagh, a long time Dalnavert volunteer who is a professional Curator and Jim Blanchard, past President of MHS and a Librarian at the University of Manitoba. Sara Hoole is on the Committee. She is part owner of Jigsaw Accessories, a boutique on Corydon Avenue. Other members are Judy Wakefield, a Chartered Accountant employed by Royal Canadian Securities, and Sarah Piercy, an Information Officer at the Winnipeg Chamber of Commerce.

With all the changes, Dalnavert is on the threshold of completely reinventing itself. Keeping the best of the old programs and developing exciting new ones, changing and improving the way in which the house is interpreted and offering a new, upgraded gift shop and a beautiful room for events, the Museum is poised to begin its second thirty years of life with a spring in its step and a twinkle in its eye.

Ross House Museum

Ross House Museum opened for the season on June 1, 2004. The museum is located in Joe Zuken Heritage Park at 140 Meade St. E between Euclid and Sutherland avenues. The house, built of oak logs between 1852 and 1854, was originally the home of William and Jemima Ross and the first post office in the northwest. The building is owned by the City of Winnipeg and the artifacts belong to the Manitoba Historical Society. The house was moved to its present site in 1984. The City pays a grant to the Society to operate the museum. The museum is a valuable learning resource on the lives of the people in the Red River Settlement as interpreted through the Ross family. The museum also helps the residents of Point Douglas to enhance their pride in the cultural heritage of their community.

Under the direction of museum manager Victor Sawelo several improvements have been made to the museum. Updated wiring and new lighting fixtures have enhanced the displays of the gallery. The alarm system was upgraded. A Canadian flag flies on our new flagpole to announce that the museum is open. The city has made repairs to the building and replaced boards on the front deck and the walkway. Two bronze plaques were remounted on the pillars at the entrance walk to the house. With the support of a special grant from Manitoba Hydro, more trees have been planted in the park.

A highlight of 2004 was the 150th anniversary of the construction of Ross House. The event was celebrated at the annual Canada Day barbecue, and over 100 people enjoyed a free meal. In addition to the usual hot dogs, we cooked up 70 pounds of bison meat that was donated this year. People also enjoyed the birthday cake, a piper, children's activities and musical entertainment. Judy Wasylycia-Leis, Member of Parliament from Winnipeg North Centre, took part in the official flag raising ceremony and the cutting of the cake. 17 members of the Ross Clan visited the house later in July and donated a book, *The Great Clan Ross*, a history of the Clan. Throughout the summer, as well as guiding tourists and other visitors through the museum, the interpreters provided craft and recreational activities for neighborhood children. Museum staff and volunteers tended the vegetable and flower garden. Produce was shared by residents of the community.

After closure at the end of August, Ross House was reopened on September 25 for special tours for more than 30 employees from Dufresne Furniture Co. who were on a scavenger hunt. The house again opened from November 27 to December 5 when the Winnipeg Film Group used it as the setting for a film production. We learned in the fall that our application for a Manitoba Heritage Grant for an outdoor interpretive sign had been approved. Volunteers participated in the required bingo and over the winter, the museum manager began arranging for the production and installation of the sign. With the support of the community and the Manitoba Historical Society Heritage Preservation Committee, walking tours are also being planned as part of the July 1 celebrations in 2005.

Museum staff members in 2004 were Victor Sawelo, museum manager; Kate MacDonald, interpreter, Andrea Mair; outreach worker and Carlos Sosa, Green Team worker. Ross House Management Committee members were Deborah Edwards, Karolyn Bradley, Don Fraser and Bill Fraser, chair, representing the Manitoba Historical Society and Point Douglas community representatives Irene Brown, Mary Mathias, Cynthia Chambers, Olive Legatti and Raymond Desjarlais. Volunteers at Ross House included committee members and Gerald Brown, Larry Condra, Sandy Dzezora and Carl James.

Accounting for Ross House is managed through the office of the Manitoba Historical Society.

Membership Committee

Four people comprised the Membership Committee during 2004/05: Carol Scott (chair), Bill Fraser, Steven Place and Gillian Covernton. The committee developed a comprehensive plan for Council approval, but scaled implementation back to reflect manpower and money limitations. Several initiatives were undertaken to encourage current members to renew and new members to join.

A mail-in membership satisfaction survey distributed with a regular mailing to the entire membership (512) and Manitoba History subscribers (88) resulted in 135 responses. Many asked for more day field trips, more frequent newsletters and Manitoba History, and development of a book club. More than two-thirds of the respondents had been members for six years or more, and fifty percent said they joined to support the society or to learn about regional history. Attendance at society events has dropped, not because of dissatisfaction, but seemingly because of membership health and safety concerns. Surprisingly all but three respondents indicated that they would pay higher membership fees, perhaps consistent with a long-term, satisfied membership base. A complete report of all results was submitted to Executive and Council and is available from the office.

Some targeted advertising was undertaken to seek new members. The Beaver Magazine donated advertisement space in one issue. Ads were placed in the newsletter suggesting memberships as gifts for Christmas or other special occasions. An ad appeared in the Manitoba Social Science Teachers Association newsletter.

A new brochure was written in house and, with the help of an outside designer, brought to camera-ready stage. Printing was delayed pending consideration of fee changes.

Other changes were made during the year. Beginning in January, the number of renewal reminder notices was reduced from three to two, to reduce mailing costs. At the time of writing, it is still too early to determine whether this change impacted membership renewal rate at all.

Also in January, Staff began to inquire and record when possible, from new members how they heard about the Society, and what interested them in joining. Being approached by an existing member and an underlying or recently developed interest in history were the most common reasons given by those new members not receiving a membership as part of a centennial award. Thirteen members joined from January to April 8 and 14 Centennial organizations received gift memberships during the same period.

The committee reviewed future database requirements. Expanding it to do more than generate address labels, and adding new fields to track committee involvement and donations were recommended, and a second review by a database expert was suggested.

MHS Heritage Trust Fund

The Manitoba Historical Trust Foundation Fund was established in June of 1984 to receive donations and administer the assets of the resulting capital fund to provide income for the operation of Dalnavert Museum and for other appropriate needs of the Society. In June of 1985 the Winnipeg Foundation was appointed custodian and manager of the capital fund.

During the past year, there were no donations to the fund. All fund-raising activities during this period were directed to the Visitor Centre Building Fund. Interest received from all investments was \$38,807.00 Dalnavert Museum was paid the amount requested for operating expenses, \$50,000.00. This amount was larger than usual because of the loss of admission income while the museum was closed and because of changes in operations as completion date of the Visitor Centre approached. No funds were transferred to the Winnipeg Foundation during this period.
